Still working on the KIDA show instead of the TOB show, Need to have a sit down with Perry Baker regarding use of the football field.

New item that we may need is a new amp. The old one is cutting out. It may just be a bad connection, but would like to have a more powerful one. It would cost about \$500 and this is something we can talk to Ms. Mitchell about regarding 1/2 the cost.

Last item we need is new drums. They are not holding their tune. The cost of these would be around \$4000.00 plus the cost of harness

### ***New Business:***

The biggest item in new business is the student accounts.

We need to make the students more vested in the band program. They need to have an idea of the cost of running the band programs.

We have two idea regarding the student accounts

The first is to have a point system in which the student would get a point or 1/2 point for every fundraiser they took part in.

The second is to have the student have a money system in which we would divide the money raised for each fundraiser by the number of people who showed up for the fundraiser. We would give each student a monthly statement so they have an idea of where they stand as well as a list of upcoming fundraiser events.

Either option would be fine with Allison who is willing to help Chris with the record keeping.

Discussions:

2. if they should show up for event, but they didn't need to where would the money go
  - a. into a trip fund
  - b. into the following year
  - c. would the money stay with the student.

takes part in after they raise their \$200 would go to cover the cost of their upcoming trip. If they don't take part in the fundraisers they will have to be responsible for the additional \$200 that it cost per student to participate in the band programs.
